PUMPKIN FESTIVAL VENDOR REGULATIONS

DEADLINE: The rolling deadline for participating as a vendor during the Pumpkin Festival (September 25th to October 31st) is the Friday prior to the weekend of attendance. For example, for September 25th, deposit/application materials are due Friday, September 24th. However, the deadline for the Chili Cook-off is October 22.

DEPOSIT: Vendors are responsible for submitting a deposit along with the application. Vendors may purchase a full weekend vendor pass for \$40 or a one day pass for \$25.

BOOTH SPACE: Vendors will receive a 10 x 10 ft. booth space. Vendors are responsible for providing booth display, tables, chairs, and tents.

EQUIPMENT: Vendors are responsible for providing their own display materials, equipment and supplies. Electricity is NOT available at the booths.

TAXES / LICENSES: All VENDORS are responsible for collecting & reporting Virginia sales tax & any other required taxes and licenses associated with their sales.

SET-UP/BREAK-DOWN HOURS: Set-up for vendors will be Saturdays from 9am to 10am and Sundays from 12noon to 1pm. Breakdown will be from 5pm to 6pm. No exceptions.

EXHIBITS: These should keep with the overall family-oriented event theme. Vendors are responsible for cleaning their booth area throughout the day and at the end of the event; use approved trash receptacles to dispose of all trash.

INSURANCE: Depending on vendor products/services, proof of liability insurance may be required.

AGREEMENT: Vendor agrees to indemnify, defend and hold Sinkland Farms, its sponsors, officers, directors, agents, employees and other related parties harmless from and against any and all liabilities, damages, losses, expenses, claims, demands, suits, fines, or judgments that include reasonable attorneys' fees, costs and expenses, incidental thereto, which may be suffered by, accrued against, charges to or recoverable from any indemnitee, by reason of any claim arising out of or relating to any act or error or omission, or misconduct of vendor, its officers, directors, agents, employees or subcontractors.
